Principal's Report

- Primary Observation Assessment (POA)
 - K-2 team is nearly finished with December assessments
 - This assessment has several components: letter identification, word test, writing vocabulary, hearing and recording sounds, and text level (fluency and accuracy).
 - Next steps are to analyze the data to determine next steps for instruction
- Elementary Concert
 - Wednesday afternoon at 1:00 pm
 - Many acts from students in K-4, plus guest appearances from 5-8 students!
- Winter Wellness
 - Permission slips have gone home
 - We will offer skiing, skating, swimming, snowshoeing and sliding this year
 - So far we have many more children scheduled to go off campus than we did last year
 - Eric Bogie and the wellness team wrote a grant that was funded y the Vermont Principal's Association
- Vermont Rural Partnership
 - 1st grade team wrote a grant to study community with their students by visiting the workplaces of their families and writing mini-books to be shared at our library and local community areas.
- BEST Institute This June a team of Barnet staff will be attending the PBiS institute for a 4 day training in strategies to use for TIER II and III students. So far attending are James Lamar, Jennifer Dodge, Ashley Gray, Jean Denson, Shawn Gonyaw and possibly two others.

- LSC Junior Interns
